Chapter One

Introduction

National statistical offices in most countries place heavy emphasis on constructing sound databases for all activities within the economic activities. PCBS initiated, in the reference year 1994, the economic surveys series. The series includes, the services survey, surveys on industry, internal trade, construction-contractors, and transport and storage sectors. The sampling frame for the different economic surveys was based on the findings of the Establishment Census 2004 conducted by PCBS.

1.1 Objectives

The objective of the survey was to obtain data on:

1. Number of enterprises and persons engaged in the economic survey series by activity.
2. Value of output, intermediate consumption and stocks.
3. Value added components.
4. Payments and transfers.
5. Assets and capital formation.
6. Contribution of the surveyed activities to the GDP and other national accounts variables.

1.2 Report Structure

The report is divided into five chapters as follows:

- **Chapter One:** Comprises an introduction to the economic surveys including survey's program, objectives, and report structure.
- **Chapter Two:** Involves the main concepts and terms used in the report with a brief description for each of them.
- **Chapter Three:** Presents the most prominent findings of the economics survey.
- **Chapter Four:** Discusses the methodology of the fieldwork in terms of questionnaire, sample, fieldwork data collection activities, and office operations. In addition, the chapter discusses data processing and tabulation.
- **Chapter Five:** Addresses the quality of the data and findings through discussing the main remarks on the fieldwork as well as comments and remarks on the tables.
- **Statistical Tables:** All tables included in this report represents Remaining West Bank and Gaza strip.

Concepts and Definitions

This chapter presents the definitions of the concepts used in the preparation of the survey tools on which data collection and processing are based. These concepts and their definitions are based on international recommendations in the fields of economic statistics and national accounts while taking into account the particular aspects of the Palestinian Territory.

Employees:

Employees include all males and females working in the establishment including owners, self-employed, unpaid family members, or waged workers who receive their compensations in cash or in kind during a specific reference period. However, this term does not include trainees or those on assignments outside the establishment or in long unpaid leaves.

Compensations of Employees:

Compensations of employees include salaries, wages, and other cash or in-kind benefits during the survey period.

Production:

Production refers to the value of goods and services produced in a certain period as a result of a main or secondary productive activity. This includes fixed assets produced for the own use of the establishment. Henceforth, production equal Value of production from main activity plus Value of production from secondary activity plus Value of own capital formation of establishment.

Production was calculated according to the market value, which represents the producer price plus value added tax on produced goods and services.

Intermediate Consumption:

It refers to the value of production inputs, i.e. inputs used in the production of goods and services. Henceforth, intermediate consumption equal value of raw material plus other production expenses.

Value Added:

It refers to production minus intermediate consumption.

Principal Economic Activity:

The principal economic activity is the activity that contributes to the largest value added in establishments practicing more than one activity.

Establishment:

An enterprise or part of an enterprise in which one group of goods and services is produced (with the possibility of having secondary activities).

Operating surplus: Value added minus (compensation of employees plus net taxes on production minus less subsidies and custom fees plus depreciation).

Gross Fixed Capital Formation: It is measured by value of acquisitions less disposals of new or existing fixed assets.

Remaining West Bank: The West Bank excluding those parts of Jerusalem, which was annexed after the 1967 occupation by Israel.

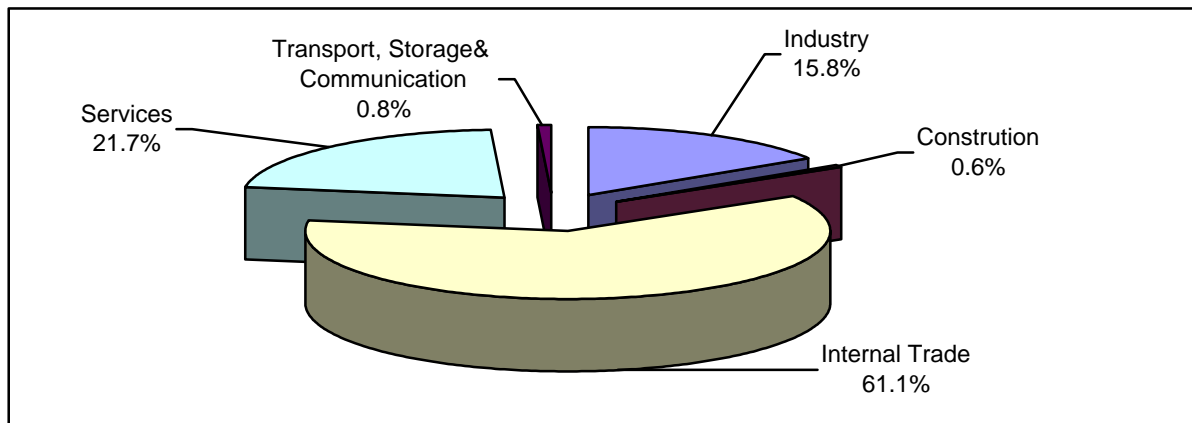
Main Findings

The prominent findings of the Economic Surveys for 2006 in Remaining West Bank and Gaza Strip are as follows:

3.1 Number of Enterprises:

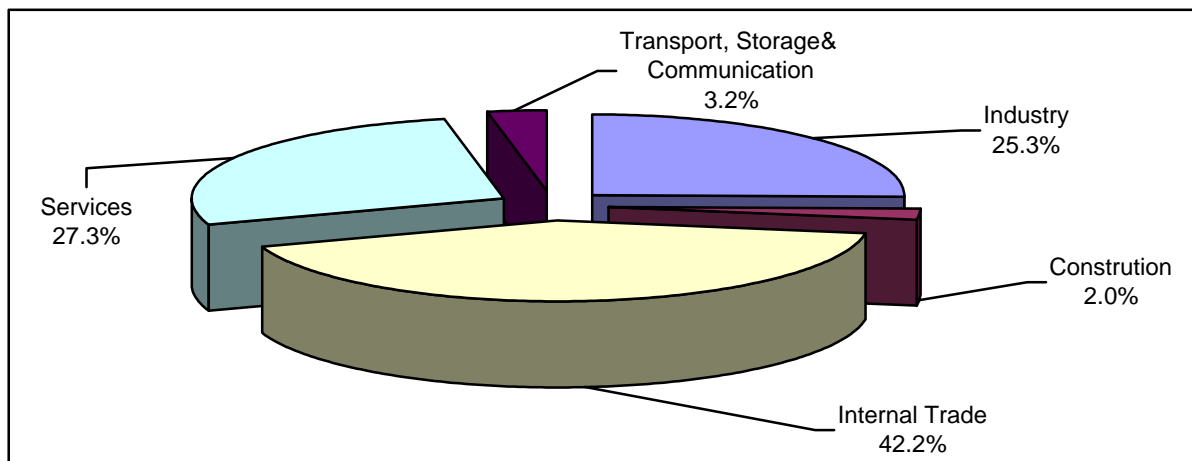
Figure (1): Distribution of Enterprises in Remaining West Bank and Gaza Strip by Economic Activity-2006

The economic results show that there are 71,966 operating enterprises during 2006 in the covered activities, in the Palestinian economy, this number was distributed as follows: industrial activities 15.8%, construction activities 0.6%, internal trade activities 61.1%, services activities 21.7%, and transport, storage and communications activities 0.8%, Figure (1) shows these results:

3.2 Number of Persons Engaged:

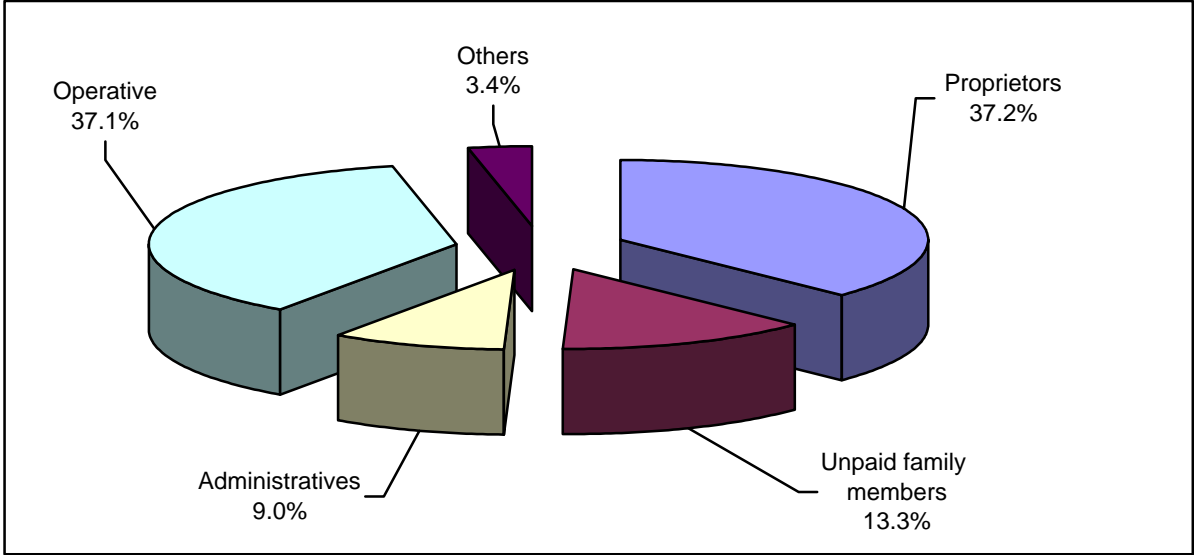
The number of persons engaged in all covered economic activities is 197,203 worker, this number was distributed as follows: industrial activity 25.3%, construction activities 2.0%, internal trade activities 42.2%, services activities 27.3%, and transport, storage and communications activities 3.2%, Figure (2) shows these results:

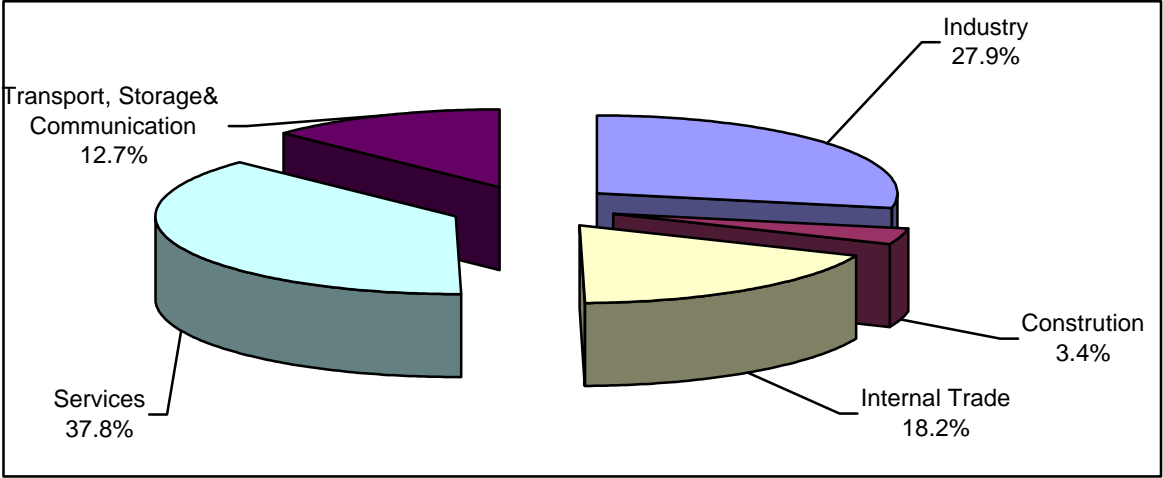
Figure (3): Distribution of Persons Engaged in Remaining West Bank and Gaza Strip by Type of Work-2006

On the other hand, the results indicate that unpaid persons engaged from proprietors have the highest percentage with 37.2 % from the total number of persons engaged, and unpaid persons engaged (unpaid family members) was 13.3 %, mean while paid employees were distributed as follows: 9.0 % for paid employees in administrative positions, 37.1 % in operative ones, and finally, others 3.4 %. Figure (3) represents these results by type of work:

3.3 Compensations of Employees:

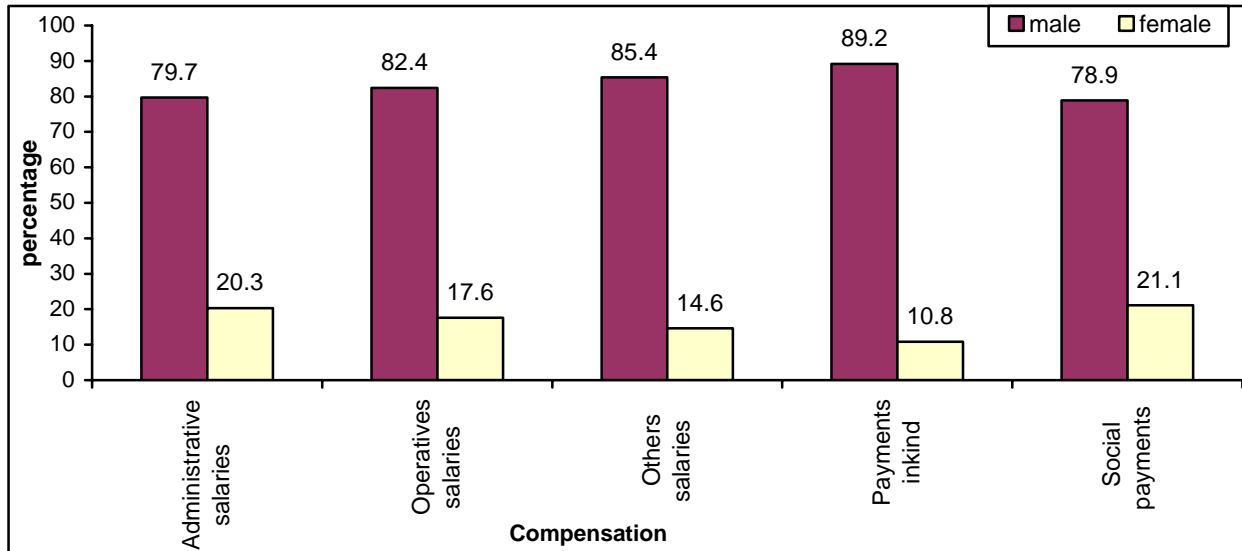
Figure (4): Distribution of Compensations of Employees in Remaining West Bank and Gaza Strip by Economic Activity-2006

The results indicate that the value of compensations of employees during 2006 in Remaining West Bank and Gaza strip was 495.5 million US\$, this value was distributed by economic activity as follows: industrial activities 27.9%, construction activities 3.4%, internal trade activities 18.2%, services activities 37.8%, and transport, storage and communications activities 12.7%. Figure (4) shows results by economic activity:

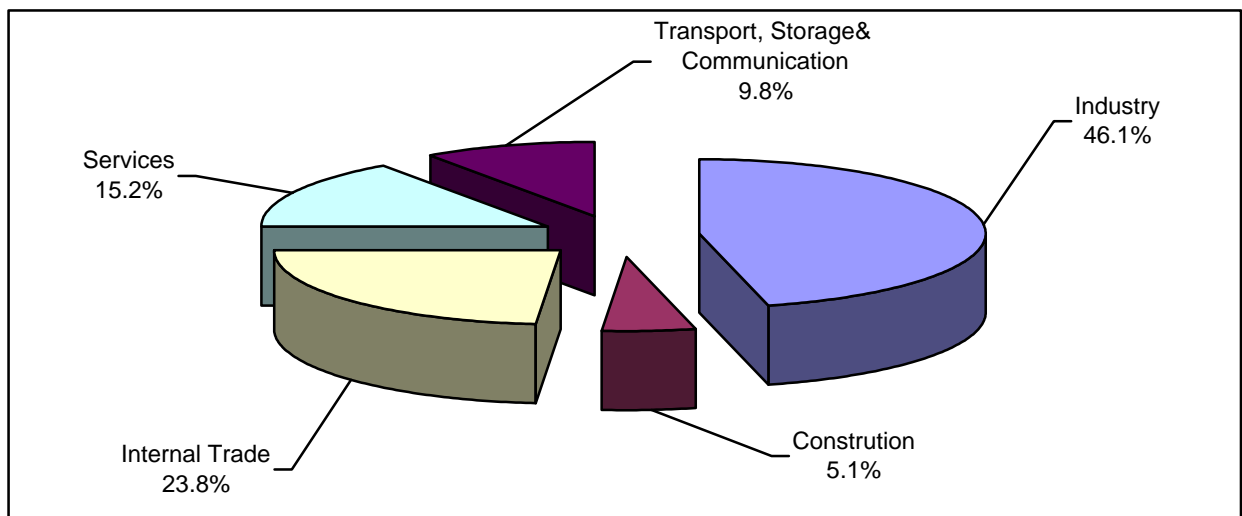
Figure (5): Distribution of Compensations of Employees in Remaining West Bank and Gaza Strip by Type of Work and Sex-2006

The compensations of employees by type of work, and by its components indicate that cash wages and salaries for paid employees in administrative positions was 136.8 million US\$,

out of it 20.3 % for female. And 314.6 million US\$ for operatives, 17.6 % of these salaries for female, 30.4 million US\$ for others, 14.6 % of these salaries for female, 6.7 million US\$ for payments in-kind, out of it 10.8 % for female. And finally, 7.1 million US\$ for social payments 21.1 % of these payments for female. Figure (5) shows these results by type of compensations:

3.4 Output:

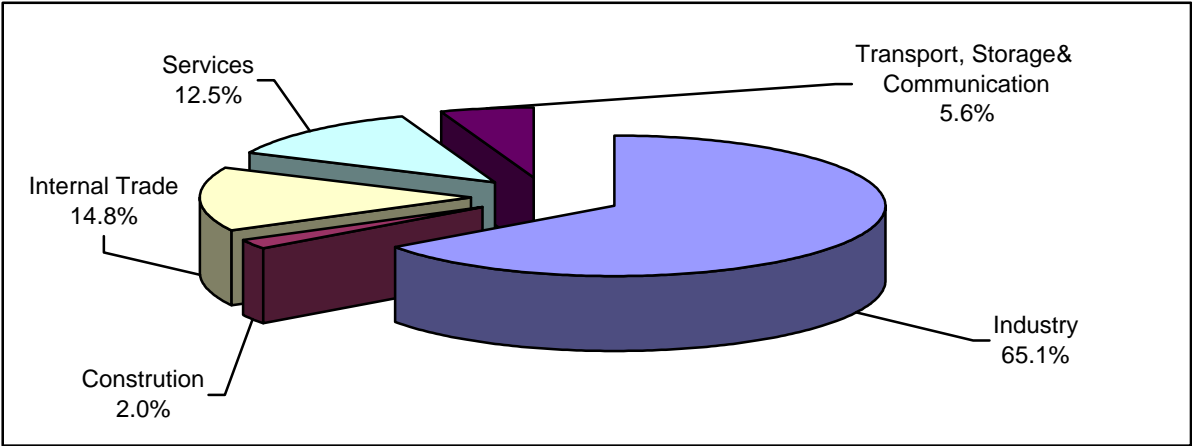
Figure (6): Distribution of Output in Remaining West Bank and Gaza Strip by Economic Activity-2006

The results indicate that the value of output in Remaining West Bank and Gaza Strip was 3,197.6 million US\$, this value was distributed by economic activity as follows: industrial activities 46.1%, construction activities 5.1%, internal trade activities 23.8%, services activities 15.2%, and transport, storage and communications activities 9.8%. Figure (6) represents results by economic activity:

3.5 Intermediate Consumption:

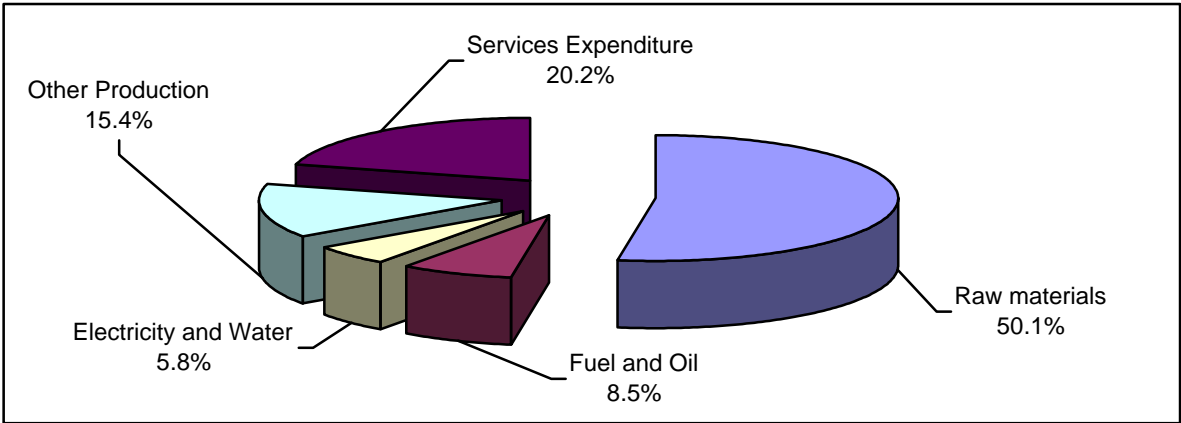
The surveys results show that the value of intermediate consumption in Remaining West Bank and Gaza Strip was 1,240.6 million US\$, this value was distributed by economic activity as follows: industrial activities 65.1%, construction activities 2.0%, internal trade activities 14.8%, services activities 12.5%, and transport, storage and communications activities 5.6%. Figure (7) shows results by economic activity:

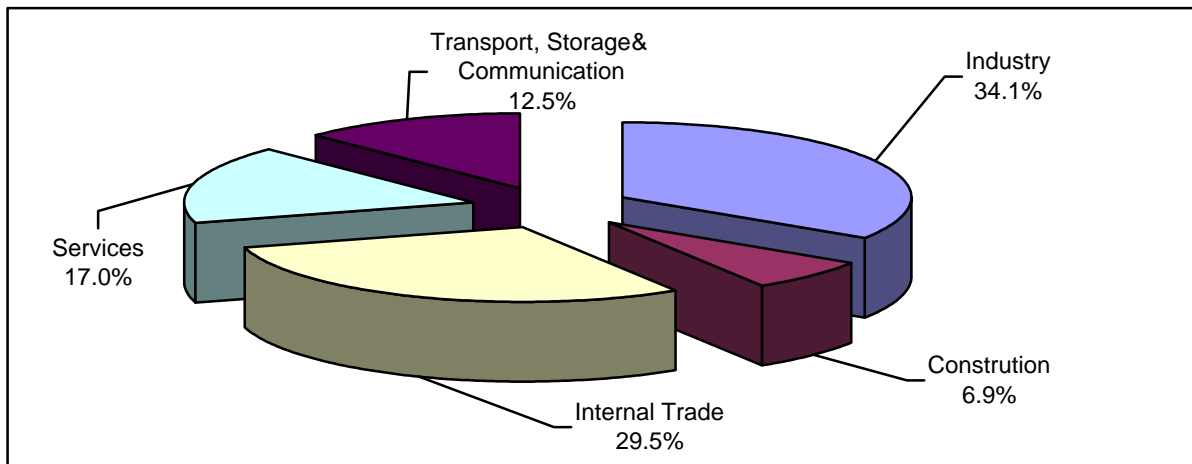
Figure (8): Distribution of Intermediate Consumption in Remaining West Bank and Gaza Strip by its Components-2006

On the other side, the results indicate that the value of intermediate consumption was distributed by its components as follows: Raw materials 50.1 %, fuel and oil 8.5%, electricity and water 5.8 %, other production inputs 15.4 %, and services expenditure 20.2 %. Figure (8) shows the results by components of Intermediate Consumption:

3.6 Value Added:

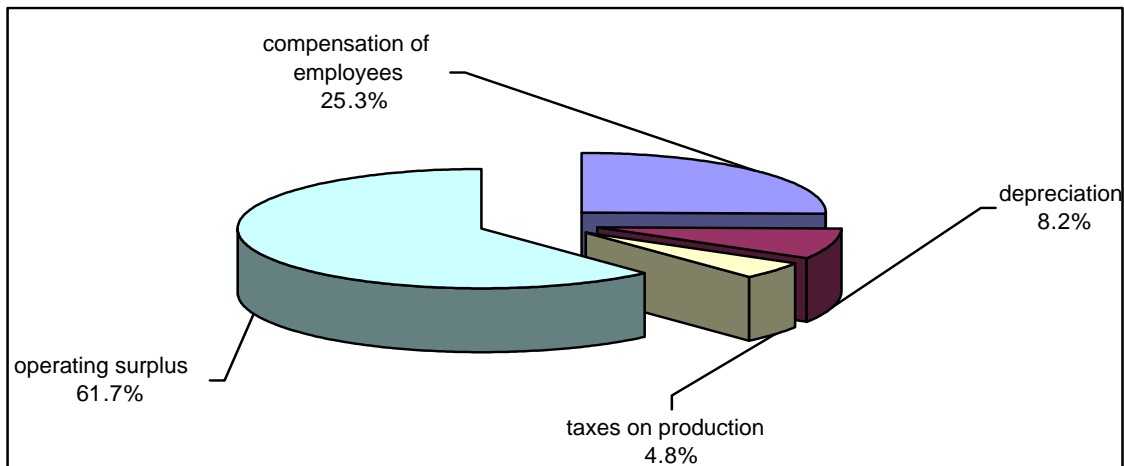
The surveys results indicate that the value added in Remaining West Bank and Gaza Strip was 1,957.1 million US\$, this value distributed by economic activity as follows: industrial activities 34.1%, constructions activities 6.9%, internal trade activities 29.5%, services activities 17.0%, and transport, storage and communications activities 12.5%. Figure (9) shows results by economic activity:

The value added was distributed by its components as follows: compensation of employees 495.5 million US\$, annual depreciation of fixed assets 159.9 million US\$, taxes on production less subsidies 94.1 million US\$, and operating surplus 1,207.5 million US\$. Methodology

4.1 Questionnaire: All of economic surveys series use the same questionnaire except for a few characteristics for each survey. The design of the 2006 questionnaire takes into account the major economic variables pertaining to the examined phenomenon, and the needs of compiling the National Accounts for Palestine.

4.2 Coverage and sampling:

4.2.1 Coverage:

The twelfth round of the Economic Survey Series Executed depending on the Establishment Census 2004, The economic surveys series covers activities in accordance with (ISIC-3):

- Industry: (C, D, E)
- Construction: (F)
- Internal Trade: (G)
- Services: (H, K, M, N, O)
- Transport, Storage and Communication: (I)

4.2.2 Sample Design:

The sample of the economic surveys series is a single-stage stratified random-systematic sample in which the enterprise constitutes the primary sampling unit (PSU). Three levels of strata were used to draw up efficient representative sample (i.e. economic activity, size of employment and geographical levels). The sample size amounted to (8,176) establishments out of the (83,158) establishments comprising the survey frame.

Response rates of Remaining West Bank and Gaza Strip:

- Response rate = (90.7%)
- Non-response rate = (9.3%)

4.2.3 The implementation stage:

This phase includes fieldwork operations, data processing and tabulation:

- Fieldwork operations: They are initiated after the training and recruitment of qualified interviewers, who are responsible for data collection from field.
- Data processing and tabulation: This part includes:
 - Developing a data entry program and training of operators
 - Organizing data entry processes
 - Post-data entry editing
 - Tabulation

Chapter Five

Data Quality

5.1 Accuracy of the Data:

5.1.1. Statistical Errors:

The findings of the survey are affected by statistical errors due to using sampling in conducting the survey for the units of the target population, which increases the chances of having variances from the actual values we expect to obtain from the data had we conducted the survey using comprehensive enumeration.. The variance of the key goods in the survey was computed and dissemination was carried out on the level of Remaining West Bank and Gaza Strip for reasons related to sample design and computation of the variance of the different indicators.

The preceding table shows the variation of the most distinct variables, where it indicates to institutions with activities that have been withdrawn sample for the rest of the West Bank and Gaza Strip, which is the activities of industry, internal trade and services. While construction activities and transport, storage and communications have no variation because of a comprehensive survey.

5.1.2. Non-Statistical Errors

These types of errors could appear on one or all the survey stages that include data collection and data entry:

Response rate values:

- Sample size was 8,176 institution in Remaining West Bank and Gaza Strip.
- Non-response cases was 679.
- Over coverage cases was 979.
- Net sample= 8,299-979= 7,320.
- Non-response rate = 9.3%.

Response errors: these types of errors are related to, responders, fieldworkers, and data entry personnel's. And to avoid mistakes and reduce the impact has been a series of actions that would enhance the accuracy of the data through a process of data collection from the field and the data processing.

Fieldwork

- Selection of specialized fieldwork team of economic back ground, the team was trained theoretically and practically on the survey questionnaire.
- The main fieldwork team was selected according to the training course.
- Field work visits by both fieldwork and project management staff for monitoring and following up data collection process and progress of work, An average of two visits for each governorate, a bout 90% of completed questionnaires was reviewed and corrected if needed, comments and notes were directed to the team accordingly.
- Different levels of supervision and monitoring toke place a according to the following division:
 - Fieldworkers
 - Fieldworkers supervisors
 - Fieldwork coordinator. (Each of them has responsibilities in monitoring)
- Project management receive a daily progress report about completeness and response.
- Conducting a refreshment training course during the stage of data collection for emphasizing the main issues of training and answering questions of fieldworkers about issues faced them in the field.

- We made another visit to some institutions which were visited by the researchers to confirm the accuracy of the data that have been given to researchers and that called the interview, these institutions has been selected randomly by withdrawing a random sample of 10% of the original sample of the survey, and then the data were compared with data from series surveys.

5.2 Data processing:

For insuring quality and consistency of data a set of measures were taken into account for strengthening accuracy of data as follows:

- Preparing data entry program before data collection for checking readiness of the program for data entry.
- A set of validation rules were applied on the program for checking consistency of data.
- Efficiency of the program was checked through pre-testing in entering few questionnaires, including incorrect information for checking its efficiency, in capturing these information.
- Well trained data keyers were selected and trained for the main data entry.
- Weekly or biweekly data files were received by project management for checking accuracy and consistency, notes of correction are provided for data entry management for correction.

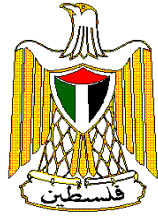
5.3 Notes on Data:

1. Differences of results of certain indicators that can be noticed are due to approximation.
2. Note that there are some economic activities to reduce second ISIC has been collecting data with the previous activity, due to maintain the confidentiality of data provided by the law of statistics for 2000.
3. According to the data of internal trade and post & telecommunications activities, the results show that there is a difference between the 2006 and 2005, because some establishments in 2005 doesn't finish their budget during the survey month of their interview results was incomplete and in 2006 their interview result completed, we observe that some of indicators such as output and value added Rises.
4. Financial data was collected by NIS, US \$ and JD, but it was converted and published in US \$.

Executive Summary

The Palestinian Central Bureau of Statistics PCBS is pleased to release the main findings of the Economic Survey Series for the year 2006. As in the previous rounds, this release covers the main economic activities practiced in the Palestinian Territory, including; Industry, Constructions, Internal trade, Transport and Communications, and Services activities. It should be mentioned that this release represents the main finding of the surveys for the Remaining West Bank and Gaza Strip, Excluding those parts of Jerusalem governorate which was annexed after the Israeli occupation in 1967.

During the year 2006, the number of persons engaged in economic activities was 197,203 worker, this number was distributed as follows:

- Industrial activities 49,990
- Construction activities 3,908
- Internal trade activities 83,312
- Services activities 53,754
- Transport, storage and communications activities 6,239

On the other side, the main findings of the surveys show that the value of the output was 3,197.7 million US\$, and this value was distributed as follows:

- Industrial activities 1,474.4
- Construction activities 160.5
- Internal trade activities 761.6
- Services activities 486.7
- Transport, storage and communications activities 314.5

Regarding the other economic indicators, the surveys results indicate that the gross value added amount to 1,957.0 million US\$, and this value was distributed as follows:

- Industrial activities 666.6
- Construction activities 135.7
- Internal trade activities 577.6
- Services activities 331.9
- Transport, storage and communications activities 245.2.
