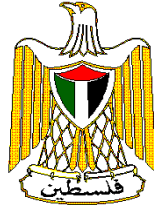

Introduction

Construction is considered to be one of the major economic activities in the Palestinian economy. It contributes substantially to the Gross Domestic Product, comprises a large share of employees, and directly influences several other economic activities. Building construction, in particular, represents one of the major construction activities.

It has been necessary for PCBS to establish a statistical database that covers several aspects of construction activities in order to accommodate the different needs of users. The annual economic surveys series conducted by PCBS as of 1994 includes a survey for construction contractors. PCBS has also conducted the Annual Existing Buildings Survey starting from the reference year 1996.

The report is divided into three chapters: chapter one presents the main findings of the project, and chapter two discusses the quality and methodology of the fieldwork in terms of questionnaire, fieldwork operations, and coverage. In addition, the chapter discusses data processing and tabulation. Finally, chapter three explains the main concepts and definitions used in the report with a brief description.

PCBS is pleased to present this report on Building License Statistics, which provides statistical data on the size and characteristics of licensed buildings in the Palestinian Territory for the fourth quarter of 2011.

The total number of building licenses issued in the fourth quarter of 2011 fell by 9.7% compared with the third quarter of the year. However, the total number of building licenses issued increased by 21.2% in the fourth quarter of 2011 compared to the fourth quarter of 2010.

1.2 Number of licenses by governorate: Nablus recorded the highest number of building licenses (391) issued for residential buildings during the fourth quarter of 2011 while Hebron governorate was second with (303) licenses. The highest number of licenses for non-residential buildings (93) was in Nablus governorate.

Chapter Two

Methodology and Data Quality

2.1 Objectives

This type of statistics provides information on the number of building licenses, the area of licensed buildings, and the number and area of licensed dwellings and stores, taking into consideration the following variables:

- Issuing authorities
- Geographic location
- Status of the buildings to be licensed (new, existing, new or existing additions)
- Ownership of building (private, governmental, local authorities, cooperative, etc.)
- Utilization of the building (residential, non-residential: industrial, commercial, educational, etc.)
- Major external construction material (stone, concrete, block etc.).

2.2 Accuracy of Data

Statistical Errors:

The survey was implemented via a comprehensive census of all studied statistical units (licenses) and therefore, is free of statistical (sampling) errors.

Non-Statistical Errors:

Non-statistical errors are probable at all stages of the project during data collection or processing. In this survey, non-statistical errors are mostly referred to as data entry errors. To avoid errors and reduce their effects, great efforts were exerted to train data entry staff on the data entry program, which was tested before commencing the actual data entry process. The data entry program was prepared prior to data collection and a set of validation rules was applied to the program to check the consistency of data. Periodic data files were received by project managers to check the accuracy and consistency of data.

2.3 Comparison of Data

Comparison exercises were carried out with surveys of building licenses for the previous and corresponding quarters and the results reveal fluctuations with previous survey data.

2.4 Technical Notes

There are important technical notes which should be taken into consideration when reviewing this report:

- Tables exclude building licenses for those parts of Jerusalem which were annexed by Israel in 1967, while (J2) includes the remaining parts of the governorate.
- The details of the value of some indicators may not add up to their total due to the rounding of calculations.
- Governorates may not appear in some tables due to the unavailability of data.

Chapter Three

Concepts and Definitions

Statistical Unit:

The license issued by any authorized authority. The issuing authorities are the reporting units for these administrative records statistics.

Building Ownership:

1. Private.
2. Governmental.
3. Local Authority.
4. Cooperative.
5. Charitable Organization.
6. Other, e.g., religious groups, UNRWA, etc.

Status of the building to be licensed:

1. New: a building that is proposed to be established on a vacant site.
2. Addition to an already existing licensed building: any addition to an existing building, whether vertical or horizontal.
3. Addition to a non-licensed existing building (or part of a building) that requires licensing.
4. Existing building.
5. Existing extension.

Building Utilization:

1. Residential: The building is considered residential if more than half of its total area is constructed for residential purposes. The building could consist of:
 - Complete dwellings.
 - Rooms added to the dwellings.
 - Extension of other facilities, e.g., kitchen, bathroom, cesspool, garage.
2. Non-Residential: When the building is not for residential purposes or more than half of its area was for residential purposes it must be classified as industrial, commercial, educational, etc.
3. The wall around the building: This is where a boundary wall undergoes separate licensing. If the building license includes the wall, then it is not included herein.

Dwelling:

A building or part of a building constructed for one household only, with one or more independent entrances leading to the public road without passing through another housing unit. The unit might not be constructed for living purposes but was found as occupied with a household during the enumeration. Likewise, the unit might be utilized for habitation or for work purposes, or for both purposes. Also, it might be closed, vacant, or occupied by one or more households during the survey.
