Important Notes

Statistics presented in this report are at constant prices, using 1997 as the base year for the period 1999-2003, and 2004 as the base year for the period 2004-2011.

Data related to the second quarter of 2011 are preliminary estimates based on the available short-term indicators, taking into consideration that the final version of the Quarterly National Accounts will be issued after finalizing the necessary indicators.

Unemployment rate in the Palestinian Territory was 18.7 percent for the 2nd quarter 2011, while it was 21.7 percent during the 1st quarter 2011 and 22.9 percent during the 2nd quarter 2010. The unemployment rate was 23.7 percent in 2010, 24.5 percent in 2009, and 26.0 percent for 2008.

The unemployment rate in the West Bank for the 2nd quarter 2011 was 15.4 percent, compared to 17.4 percent during the 1st quarter 2011 and 15.2 percent during the 2nd quarter 2010. In the Gaza Strip, unemployment rate was 25.6 percent for the 2nd quarter 2011, compared to 30.8 percent during the 1st quarter 2011 and 39.3 percent during the 2nd quarter 2010.

Data related to Government (education, health, public administration and defense) were valued using Accrual Bases based on the recommendations of the System of National Accounts. Wages and salaries were obtained from the monthly report of the Ministry of Finance to estimate government activities, taking into consideration that data pertaining to expenditures in the public budget were reclassified based on the latest revision to the Government Finance Statistics Manual 2001.

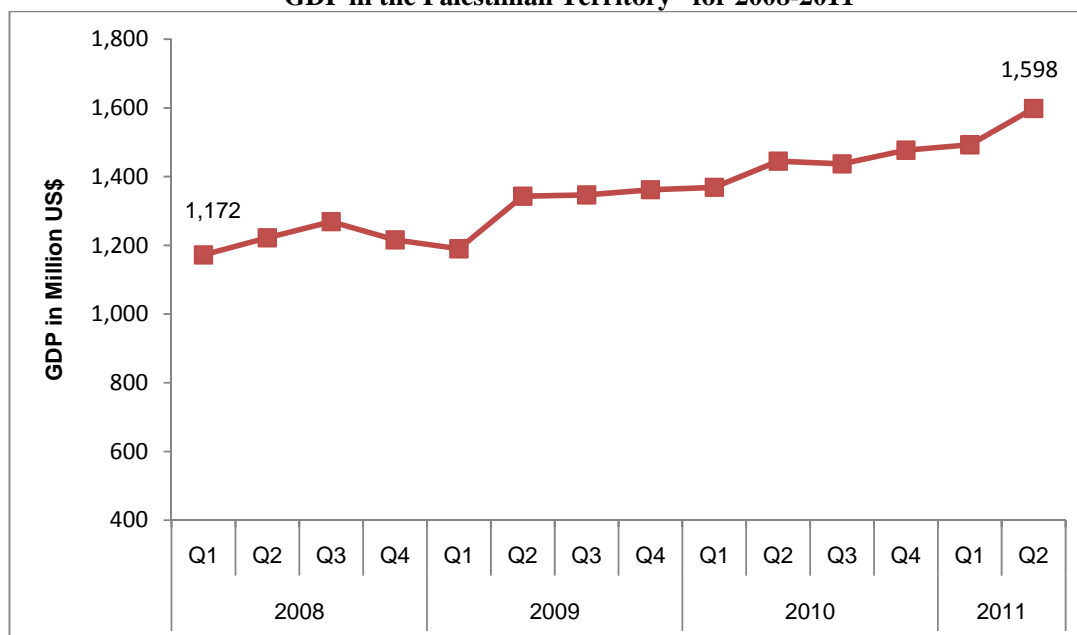
Value Added of Construction Activity Increased by 23.7 Percent

In the 2nd quarter 2011, the value added of construction activity increased by 23.7 percent in the Palestinian Territory* in comparison with the 1st quarter. In mining and quarrying, the value added fell by 29.0 percent.

An increase in GDP during the 2nd quarter 2011 compared to the 1st quarter 2011

Preliminary estimates at constant prices showed an increase of 7.1 percent in GDP in the Palestinian Territory* during the 2nd quarter 2011 compared to the 1st quarter 2011, while estimates showed an increase of 10.6 percent compared to the 2nd quarter 2010 at constant prices (base year 2004). In the West Bank,* GDP increased by 7.4 percent during the 2nd quarter 2011 compared to the 1st quarter 2011. In the Gaza Strip, GDP increased by 6.0 percent during the 2nd quarter 2011 compared to the 1st quarter 2011. GDP for the 2nd quarter 2011 at constant prices in the Palestinian Territory* was US\$ 1,598 million, of which US\$ 1,172 million was for the West Bank* and US\$ 426 million for the Gaza Strip.

Gross Domestic Product Per Capita

GDP per Capita for the Palestinian Territory* was US\$ 409 during the 2nd quarter 2011, an increase of 6.3 percent compared to the 1st quarter 2011 and an increase of 7.4 percent compared with the 2nd quarter 2010.

Performance of Main Economic Activities during 2nd Quarter 2011 in the Palestinian Territory*.

First: There was an increase in the gross value added for the following economic activities:

- The gross value added for **Mining, Manufacturing, Water and Electricity** activities increased during the 2nd quarter 2011 compared to the 1st quarter 2011 by 6.5 percent and increased by 16.6 percent compared to the 2nd quarter 2010.
- The gross value added for **Public Administration and Defense** activities increased by 1.9 percent during the 2nd quarter 2011 compared to the 1st quarter 2011 and increased by 14.7 percent compared to the 2nd quarter 2010.
- The gross value added for **Construction** activities increased by 23.7 percent during the 2nd quarter 2011 compared to the 1st quarter 2011 and increased by 33.0 percent compared to the 2nd quarter 2010.
- The gross value added for **Wholesale and Retail Trade** activity increased by 7.9 percent during the 2nd quarter 2011 compared to the 1st quarter 2011 and increased by 7.3 percent compared to the 2nd quarter 2010.
- The gross value added for **Transport, Storage and Communications** activities increased by 8.4 percent during the 2nd quarter 2011 compared to the 1st quarter 2011 and increased by 5.5 percent compared to the 2nd quarter 2010.
- The gross value added for **Agriculture and Fishing** activity increased by 2.9 percent during the 2nd quarter 2011 compared to the 1st quarter 2011 and increased by 2.4 percent compared to the 2nd quarter 2010.
- The gross value added for **Education** activity increased by 7.3 percent during the 2nd quarter 2011 compared to the 1st quarter 2011 and increased by 12.7 percent compared to the 2nd quarter 2010.

Second: There was a decrease in gross value added for the following economic activities:

- The gross value added for **Real Estate, Rental and Business Services** activities decreased by 2.4 percent during the 2nd quarter 2011 compared to the 1st quarter 2011 and increased by 3.8 percent compared to the 2nd quarter 2010.

Concepts and Definitions

Statistical Unit

The United Nations System of National Accounts, SNA 1993, defines two main types of statistical units:

- Institutional Unit-Enterprise

An institutional unit is an economic entity that is capable, in its own right, of owning assets, incurring liabilities, and engaging in economic activities and transactions with other entities.

- Establishment

An establishment is an enterprise, or part of an enterprise, which produces only a single group of goods (with the possibility of production from secondary activities) in which the principal productive activity accounts for most of the value added.

Breaking down institutional units into establishments serves to create more consistent statistical units in the productive sense.

Economic Activity

Is an activity carried out under the responsibility, control and management of an institutional unit that uses inputs of labour, capital, goods and services to produce outputs.

Output

Value of goods and services, including own-account goods, produced during a specific period.

Value Added

Value added is a central concept of production and refers to the generated value of any unit that carries out a productive activity. Gross value added is defined as the value of gross production less the value of intermediate consumption. The net value added is defined as the gross value less the value of fixed capital consumption. The net value added reflects the performance of the economy in a better way but, since it is difficult to measure the fixed capital consumption accurately, the concept of gross value added is more frequently used.

Value added at producers' price is the difference between output at basic prices and the value of the intermediate consumption at purchase price plus taxes (less subsidies) on production. However, if taxes and subsidies are excluded, value added will be obtained in basic prices.

Gross Domestic Product (GDP)

Gross Domestic Product or GDP is the summary measure of the output or production during a certain period in time. An estimate of GDP, like the output and the value added, can vary according to taxes and subsidies, taking into consideration that GDP is usually estimated at market prices, producers' prices, or basic prices.

Deflating

Changing all data at current prices to constant prices by choosing the suitable indices by which the effect of prices on the data will be isolated and choosing a suitable base year in order to do this.

Short-term Indicators

All indicators that have a periodicity of less than a year: usually a month or a quarter.

Industrial Production Index

A statistical tool used for measuring the change in volume of output of industrial activities during a certain period of time. The index uses the change in volume of production for the largest establishments in each industry.

Financial Intermediation Services Indirectly Measured (FISIM)

It refers to the total property income payable to a financial institution, less the gross value of payable interest on these institutions, excluding property income from investment of money of the same institutions.
