### Sharp Increase in Wholesale Price Index during 2024 and the fourth quarter of 2024

### Sharp Increase in Wholesale Price<sup>1</sup> Index by 15.93% during 2024


The overall **Wholesale Price Index** in Palestine during 2024 **recorded a sharp increase by 15.93%** compared with 2023 (**32.83%** for local consumed products, and by **9.61%** for imported products).

The changes in WPI for 2024 were traced back to changes in prices of the following Division

compared with previous year:

Division during 2024	Percent Changes
Wholesale trade, except of motor vehicles and motorcycles	+17.65%
Wholesale and retail trade and repair of motor vehicles and motorcycles	+1.49%

# Sharp increase in the wholesale price index in Palestine by 17% since the beginning of the Israeli aggression on Gaza Strip

The overall **Wholesale Price Index** in Palestine during the Fourth Quarter of 2024 **recorded an increase by 5.04%** compared with the Third Quarter of 2024 (10.46% for local consumed products, and by 2.61% for imported products).

The changes in WPI for the Fourth Quarter of 2024 were traced back to changes in prices of the following Division and Category compared with previous quarter:

  (UN), to classify wholesale trade division and
  category within section G "45-47" wholesale and
  retail trade; repair of motor vehicles and
  motorcycles, exclude division 47 for retail trade.
- Due to the Israeli attack on Gaza strip in October,7
  2023, the wholesale prices in Gaza strip was
  estimated according to international
  recommendation in this field for Fourth quarter
  2024.
